

# LAA Responds to Task Force Recommendations

The following letter was sent to Rutgers University President Richard L. McCormick by Yash Dalal, President of the Livingston Alumni Association.

Dear President McCormick:

On behalf of the Livingston Alumni Association (LAA), thank you for taking the time to hear our concerns regarding the recommendation of the Task Force on Transforming Undergraduate Education at Rutgers University. The LAA agrees that the Task Force has recognized certain critical problems at Livingston College and Rutgers University, which undoubtedly, need solutions. However, we remain adamantly opposed to the drastic recommendation that Livingston College is eliminated and all the undergraduate colleges at Rutgers be combined into one College of Arts & Sciences. We strongly feel that Livingston College can become a much more successful, appealing and more dynamic learning institution by taking less severe steps than elimination, while still retaining autonomy at a campus level.

Livingston College can become a true college of choice at Rutgers. Unfortunately, Rutgers and Livingston College have not done a sufficient job at promoting the brand of Livingston College as a smaller, unique learning environment within a large research university, having the benefits of

Although we appreciate your time and efforts to hear our issues with the report, we feel that too many questions remained unanswered. The Task Force extols the merits of having one centralized undergraduate College of arts & Sciences sciences of 20,000 students; however, we see many drawbacks to this structure. For example, leadership opportunities for students and alumni will greatly diminish. As Livingston alumni, we greatly benefited from the close, meaningful interaction and involvement we had with other students, faculty and advisors during our undergraduate years. This camaraderie and fellowship simply cannot exist in a combined university with almost twenty thousand undergraduates, particularly when students may not live on the same campus each year. Education does not end in the classroom, and these diminished leadership opportunities are a detriment for future students.

Livingston College also provided specialized career services for its students. Students were able to receive sincere guidance close at hand. With 18,000 students sharing a centralized career services, how much time will each student legitimately have with a counselor? The LAA is deeply concerned that students will receive something akin to "fastfood" guidance and counseling, which is not meaningful and may discourage students from seeking guidance at all.

We also oppose the recommendation for a centralized system for student activities and the collection of student fees. The increased bureaucracy may prevent students from actually receiving the money to which they are entitled in order to fund activities and groups. If the student centers at the campus level controlled the fees and resources, it would ensure that the funds are properly and equally distributed.

Overall, we feel that a centralized system is not automatically a better system. The LAA fears that creating a monolith will diminish the creative and inspirational features which already exist at Livingston College.

The LAA is also concerned about the University's limited resources and the dim prospects for vast amounts of new capital. If the University decides to implement all the recommendations in their entirety, without adequate funding, some of the main features of the overhaul may not even come to fruition, such as creating new buildings, adding faculty and improving services. Without the adequate resources to fund the lofty goals of the Task Force, the entire university community may even suffer.

The LAA and the Task Force have similar goals. We both seek to improve the university community and ultimately provide a better experience for students. However, the Task Force report leaves too many holes and unanswered questions. The implementation stage is too late to have our concerns resolved. Livingston students and alumni need to fully understand what will become of the many services and benefits Livingston College has offered for 37 years. And, time is of the essence, because our concerns should be addressed before a plan is put into action. Otherwise, our issues become moot.

If the University ultimately decides to eliminate the unique, distinctive colleges at Rutgers to create a colossal

undergraduate college over the objection of many in the Rutgers community, we offer a recommendation. The Task Force suggests that students should affiliate with a campus during their third year. We feel this defeats the purpose of having affiliations. The first year of college is a critical time for students. Livingston College, as an autonomous institution, offered students a myriad of opportunities to get involved from Day One. Rutgers should maintain this procedure and have students affiliate with a campus before they begin their first year. This allows for continuity of networking and leadership opportunities.

In addition, the existing problems facing Livingston will not be fixed merely by expanding the student center and building College Town. Livingston needs a new academic building and new dormitories. In addition, we also suggest that the reputation of Livingston College would vastly improve if a major academic department was stationed at Livingston. For example, if the Economics department was located at Livingston, it could be a logical link to the Business School, already located on the Livingston campus.

Whichever path the University chooses, we implore you to include the voices of Livingston College alumni and students during the finalization of the recommendations and in the implementation process. The proposed restructuring should not diminish the voices of over 22,000 Livingston current and future alumni who are very proud of their college.

### LAA SHARES TASK FORCE VIEWS WITH UNIVERSITY ADMINISTRATION

The Livingston Alumni Association members and officers participated in a number of key meetings with Rutgers University leadership in the Fall 2005 to express the opinions of alumni regarding the recommendations of the Task Force Report on Transforming Undergraduate Education. These meetings took place on:

- October 11, in conjunction with the Ad-Hoc Committee of Rutgers University trustees studying the Task Force Report
- November 15, where a Forum was held on the Livingston College campus
- December 1, in conjunction with a meeting with Rutgers University
   President Richard McCormick and Professor Barry V. Qualls, Chair of the Task Force

A key recommendation of the Task Force is to let students choose a Rutgers campus as their residence each year. During the October 11 presentation to the Ad-Hoc Committee to the Rutgers trustees body, LAA President Yash Dalal and Vice President Jason Goldstein, along with Livingston College President Dean Arnold Hyndmann, each agreed that the current physical plant at Livingston needed extensive upgrading in order to attract students to make Livingston their choice as a residential area.

At the November 15 Task Force Forum, held in the Lucy Stone Auditorium on the Livingston Campus, President McCormick and members of the Task Force panel heard testimony from a number

of students, alumni and faculty regarding the effects that the recommendations to fold Livingston College, along with Cook College and Douglass College into one Rutgers College of Arts & Sciences. Hundreds of students, faculty and alumni packed the forum room to hear remarks from Dean Hyndmann and a panel of their peers. Audience members also had the opportunity to add their voice to the panel's testimony. One audience participant was Rob Bertrand, a member of the LAA Board and advisor to The Core, Livingston's student radio station, who said that Livingston's small college within a larger University setting offers students increased opportunities to gain leadership skills and life education that would not otherwise be available at a merged University setting. Lynn Astorga, also an LAA board member, stressed the need to allocate major resources to upgrade Livingston's campus and keep the college's programs in place, particularly since many of the college's activities are being emulated by other Rutgers campuses, as well as other universities throughout the country.

Jason Goldstein, a vice president of the LAA board, spoke about the entrepreneurial opportunities that were available at Livingston College for him, including the opportunity to start a theater company on the Livingston campus that is being touted as a cornerstone of the proposed College Town complex. "Without the diversity of Livingston's life and teaching experiences, I would not have developed the business and life skills needed to take me on this career path," said Goldstein.

In an effort by the LAA to present more information about the effects of the Task Force's recommendations on the future of Livingston College, an invitation was extended to Rutgers University President Richard McCormick and Barry Qualls, chair of the Task Force, to attend a December 1 meeting of the LAA board. President McCormick and Professor Qualls participated in a lively discussion with board members about the feedback they have received from the Task Force forums and the need expressed by LAA board members to continue to maintain Livingston's programs and unique opportunities for student learning and life skills intact. President McCormick told the board he would be submitting his response to the Task Force's recommendations in February 2006.
